- 3) Must not have failed a previous placement in the EHD Program.
- 4) Must not be convicted for what would be an A or B Felony or a Level 1, 2, 3 or 4 Felony
- 5) Must not have been convicted of a drug dealing offenses (except for marijuana as a misdemeanor).
- 6) May be rejected by Community Corrections staff based on prior criminal history.
- 7) May be rejected from the EHD program based on other residents living in the home.
- 8) Must have the final approval of the Community Corrections Director.
- 9) The preferred length of sentence shall not exceed one and a half years in actual length.
